

**ORDINANCE 2016-02**

**AN ORDINANCE APPROVING THE RECODIFICATION, EDITING AND INCLUSION OF CERTAIN ORDINANCES AS PART OF THE VARIOUS COMPONENT CODES OF THE CODIFIED ORDINANCES OF HIRAM, OHIO**

**WHEREAS**, various ordinances of a general and permanent nature have been passed which should be included in the Codified Ordinances of Hiram, Ohio.

**WHEREAS**, numerous sections in the Traffic, General Offices and Fire Prevention Codes need to be amended or enacted so as to conform to State law;

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF HIRAM**, Portage County Ohio, two-thirds or more of the members elected thereto concurring that:

**SECTION 1:** That the recodification, editing, arrangement and numbering or renumbering of the following ordinances and parts of ordinances are hereby approved as parts of the various component codes of the Codified Ordinances of Hiram, Ohio, so as to conform to the classification and numbering system of the Codified Ordinances, to wit:



**SECTION 5:** That this ordinance shall take effect and be in force from and after the earliest period allowed by law.






