ORDINANCE 2020-19

**AN ORDINANCE AMENDING THE PERMANENT APPROPRIATIONS IN THE NEW SPECIAL REVENUE FUND (2913) AND DECLARING AN EMERGENCY.**

**WHEREAS**, funds were awarded to the State of Ohio as Federal Financial Assistance from the U.S. Department of Treasury; and

**WHEREAS**, funds were awarded under the Social Security Act, as amended by section 5001 of the Coronavirus Aid, Relief, and Economic Security Act ('CARES Act') as the Coronavirus Relief Fund (CRF); and

**WHEREAS**, a Special Revenue Fund needed to be established to receipt in these Coronavirus Relief Funds; and

**WHEREAS**, recently received funds in the Local Coronavirus Relief Fund #2913 must be appropriated in order to cover expenses relating to the coronavirus pandemic; and

**NOW, THEREFORE, BE IT ORDAINED**, by the Council of the Village of Hiram, Portage County, Ohio with two-thirds or more of the members elected thereto concurring, that:

**SECTION 1:** The permanent appropriations in the Local Coronavirus Relief Fund (2913) are ZERO. The appropriations will be increased by \$64,285.46. The new total appropriations for Fund 2913 will be \$64,285.46.

**SECTION 2:** This Ordinance is declared an emergency measure becoming effective immediately upon its passage by Council and approval by the Mayor to maintain correct accounting practices, to pay the current and imminent financial obligations of the Village and to utilize these special relief funds in the timeframe that is provided by the State of Ohio, and for that reason this Ordinance shall take effect immediately upon proper passage by Council.

**SECTION 3:** It is hereby found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its Committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Revised Code of the State of Ohio.
