

RESOLUTION 2007-11

A RESOLUTION AUTHORIZING SPECIFIC ENUMERATED TRANSFERS BY THE FISCAL OFFICER BETWEEN FUNDS OF THE VILLAGE OF HIRAM.

WHEREAS, there are unclaimed funds that have been in the unclaimed fund (9101) for at least five years and;

WHEREAS, these amounts can be transferred to the General Fund (1000) and;

WHEREAS, anyone who has unclaimed funds that have been moved to the General Fund may claim them at any time in the future.

NOW THEREFORE, BE IT RESOLVED, by the Council of the Village of Hiram, Ohio a majority of its members concurring that:



The total unclaimed funds from 1999 are \$125.16, 2000 are \$34.67 and 2001 are \$85.81 making the total to be transferred to the General Fund \$245.64. The funds from 1999 will be transferred from Unclaimed Funds 9101-910-910-0000 to General Fund 1000-931-0409 in the amount of \$125.16. The funds from 2000 will be transferred from Unclaimed Funds 9101-910-910-0000 to General Fund 1000-931-0410 in the amount of \$34.67. The funds from 2001 will be transferred from the Unclaimed Funds 9101-910-910-0000 to the General Fund 1000-931-0411 in the amount of \$85.81.

SECTION 2: Check # 30664 in the amount of \$4.86 made to Terrence Johnson on May 9, 2006 has never been cashed. Attempts to contact Mr. Johnson have failed. This money will need to be transferred from the General Fund 1000-910-910-0000 to the Unclaimed Fund 9101-931-0000.

SECTION 3: It is hereby found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council and that the deliberations of the Council and any of its committees that resulted in such formal action were in meetings open to the public sale in compliance with all legal requirements including Section 121.22 of the Revised Code of the State of Ohio.
