RESOLUTION NO. 2022-25

A RESOLUTION AUTHORIZING A CONTRACT WITH WORKMAN INDUSTRIAL SERVICES, INC. FOR THE WATER TOWER REPLACEMENT PROJECT WITHIN THE VILLAGE OF HIRAM, PORTAGE COUNTY, OHIO AND DECLARING AN EMERGENCY

WHEREAS, the Council of the Village of Hiram has previously passed Resolution 2019-04 declaring the need to replace the existing Village Water Tower; and

WHEREAS, the Village of Hiram has previously advertised for bids for the Water Tower Replacement Project; and

WHEREAS, advertisements were made in the Record Courier, a newspaper of general circulation within the Village of Hiram, on June 30, 2022, and July 7, 2022, that sealed bids for the Water Tower Replacement Project would be received at the Village Fiscal Officer's office within the Village of Hiram until 12:00 p.m. on July 21, 2022; and

WHEREAS, sealed bids were received by the Village of Hiram from three contractors; and

WHEREAS, the sealed bid from Workman Industrial Services, Inc. in the amount of One Million Seventy-Nine Thousand Seven Hundred Thirteen Dollars & 00/100 (\$1,079,713.00) is the lowest bid that has been received; and

WHEREAS, CT Consultants, the Village consulting engineer has checked the references of Workman Industrial Services, Inc. and has found that the references demonstrate that Workman Industrial Services, Inc. to be a responsible and responsive company, capable of performing under the contract if the contract is awarded to them; and

WHEREAS, CT Consultants has recommended that Workman Industrial Services, Inc. has submitted the lowest responsive and responsible bid and that the Water Tower Replacement Project contract should be awarded to Workman Industrial Services, Inc.

NOW THEREFORE BE IT RESOLVED by the Council of the Village of Hiram, State of Ohio, two thirds or more of the members thereto concurring that:

Section 1: The actions of the Village Administrator and the Village Engineer in advertising the Water Tower Replacement Project are hereby ratified, confirmed and approved.

Section 2: The bid of Workman Industrial Services, Inc. is less than the Opinion of the Probable Construction Cost of \$1,200,000.00. The recommendation of CT Consultants that the contract should be awarded to Workman Industrial Services, Inc. is hereby accepted.

Section 3: That the bid submitted by Workman Industrial Services, Inc. is declared to be the lowest responsive and responsible bid.

Section 4: That a contract, in substantial conformity with that attached hereto and marked for identification as Exhibit "A" between Workman Industrial Services, Inc. and the Village of Hiram, is hereby authorized. The Mayor and the Fiscal Officer are directed to execute a contract in substantial conformity with the attached Exhibit "A".

Section 5: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were accepted in an open meeting of this Council, and that deliberations of this Council and any of its committees that resulted in such formal actions were in meetings open to the public in compliance with Section 121.22 of the Ohio Revised Code.

Section 6: This Resolution is hereby declared to be an emergency measure, becoming effective immediately on passage by Council and approval by the Mayor, in order to advance the health, safety and general welfare of the Village of Hiram, and for the further reason that the Village must move forward expeditiously to assure a continuing and uninterrupted supply of healthy, potable water to the residents and other customers of the Village water system.
