

RESOLUTION 2024-14

**A RESOLUTION AUTHORIZING THE APPLICATION FOR AND SUBSEQUENT ACCEPTANCE OF GRANT FUNDS BY THE VILLAGE OF HIRAM FROM THE HIRAM COMMUNITY TRUST AND RATIFYING PAST ACTIONS WHICH ARE NOW AUTHORIZED BY THIS RESOLUTION AND DECLARING AN EMERGENCY.**

WHEREAS, the Hiram Police Department holds numerous community policing programs. The Hiram Police Department has limitations within their budget to continue running these programs; and

WHEREAS, the Hiram Police Department submitted an application to the Hiram Community Trust for an \$1,100.00 grant to help cover costs incurred with the "Bike Rodeo," "Fishing with a Cop" and "Halloween Safety Night" Programs; and

Whereas, the Village of Hiram is likely to be a successful candidate upon application for the grant funds to be made available.

**NOW THEREFORE BE IT RESOLVED** by the Council of the Village of Hiram, Ohio, two-thirds or more of the members elected thereto concurring that:


**SECTION 1:** The actions of the Hiram Police Department in applying to the Hiram Community Trust for grant funding for the 2024 "Bike Rodeo, Fishing with a Cop and Halloween Safety" Programs are hereby ratified and approved.

**SECTION 2:** The Council of the Village of Hiram authorizes the Fiscal Officer to accept funds from the Hiram Community Trust for the 2024 "Bike Rodeo, Fishing with a Cop and Halloween Safety" Programs.

**SECTION 3:** This Resolution is hereby declared to be an emergency measure, the particular emergency being the grant has already been applied for by the Hiram Police Department.

**SECTION 4:** It is hereby found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Revised Code of the State of Ohio.
